**ELECTION DAY: NOV. 5**

**INFLATION: CUT REGULATIONS TO BRING DOWN PRICES**

Cut government regulations & spending to bring down cost of goods for citizens.

**IMMIGRATION: OPEN BORDER POLICIES**

Fund sanctuary cities, help illegal immigrants avoid deportation, decriminalize illegal border crossings, provide amnesty. Release illegal immigrants into communities.

**ENERGY INDEPENDENCE: FRACKING, DRILLING & KEYSTONE XL PIPELINE**

Protect domestic drilling, fracking & Keystone Pipeline to bring down prices. Government should buy American & hire American.

**NONCITIZENS: BENEFITS & RIGHT TO VOTE**

Citizens should pay for healthcare, education, & housing for illegal immigrants & refugees. Eliminate voter I.D.

**ECONOMY: CUT TAXES**

Make income tax cuts permanent. Cut taxes on capital gains, corporate income, & estates. Terminate payroll & Social Security taxes. No new taxes on natural gas, carbon, or 401(k)s.

**HEALTHCARE: KEEP PRIVATE INSURANCE**

Protect private insurance. Citizens should not be required to pay for healthcare for noncitizens.

**GOVERNMENT CONTROL: VACCINES & ELECTRIC VEHICLES**

Mandate COVID-19 vaccine. Phase out gas vehicles to force transition to electric within 10 years.

**BABIES BORN ALIVE: REQUIRE MEDICAL CARE**

Babies born alive after surviving a failed abortion attempt have the right to life-saving medical care.

**TRANSGENDER AGENDA**

Allow males identifying as females in female sports. Include sexual ideology in grade schools. Citizens should pay for sex changes for prisoners.

**BLACK COMMUNITY: SUPPORT FOR HBCU & FIRST STEP ACT**

Financial support for Historically Black Colleges and First Step Act that disproportionately impacts young black men.

**LATE-TERM ABORTION & TAXPAYER FUNDED ABORTION**

Women have a right to abort their babies through the ninth month. Taxpayers fund abortions.

**DEFUND THE POLICE: REMOVE POLICE FROM SCHOOLS**

Defund police or reimagine policing. "Taking police officers out of schools." Raising money for BLM rioters who burn down police stations and businesses.

**GUN CONFISCATION**

Government may take guns from law-abiding citizens via bans or mandatory buybacks.

**REQUIRE CITIZENSHIP & VOTER I.D. TO VOTE**

Require photo I.D. to vote. Eliminate drop boxes.

**PROTECT RELIGIOUS FREEDOM**

Catholic & other religious businesses may opt-out of providing services in violation of their faith. Catholic/Christian beliefs do not disqualify judicial nominees.

**RELEASE PRISONERS; ALLOW PRISONERS TO VOTE**

Release prisoners. Consider allowing prisoners to vote. End cash bail, including, for rioters.
